Helping adoptive parents get the money they deserve!

- Did you finalize an adoption in 2011?
- Was the adopted child in the foster care system?
- Do you earn less than \$225,000 per year?

If so, you may qualify to receive a federal income tax credit of \$13,360 for that adoption. The adoption credit is refundable to adoptive families, even if they have no income or pay no taxes. In other words, you may qualify to receive a \$13,360 tax-free refund per child.

Adoption Credit for Qualifying Years:

2011	\$13,360
2012*	\$12,650
2013*	\$12,970
2014*	\$13,190

The adoption credit is a one-time credit per qualified adopted child.

* Adoptions in 2012—2014:

Adoptions in 2012—2014 are still eligible to apply for the Adoption Tax Credit. However, claiming them from the IRS differs from years past. Please contact our office for a free review of your returns.

Example A

A family adopted 2 qualified children in 2011. This family can claim a maximum of \$13,360 per child for a total refund amount of \$26,720.

Qualifying for the Adoption Credit without Claiming Adoption Related Expenses:

To benefit from the Adoption Tax Credit, the following requirements must be met:

- A family must have adopted a child from the foster care system.
- The adopted child(ren) must have received a monthly post-adoption subsidy from the state after the adoption was finalized.
- A family should have a total modified gross income of under approximately \$225,000 in order to receive an adoption credit. The adoption credit phases out at a specific income level. The exact amount of income varies from year to year.

Process of Claiming the Adoption Credit:

The IRS requires certain documents to review and approve the credit reimbursement. We request that you provide us with the following documents:

- Adoption Order or Final Judgment of Adoption for each qualifying child;
- A signed post-adoption subsidy agreement issued by the state or other certified document that you receive or have received confirming assistance from the state; and
- Copy of your 2011 Federal Tax Return. If you did not file taxes in 2011, our office will prepare an original tax return to request the adoption credit for all qualifying adoptions.

It is very important for you to notify the support group facilitator before <u>every</u> support group meeting. Please let the support group facilitators know <u>at least 3 days in advance</u> (if possible) that you plan to attend a meeting. (We understand that unexpected changes happen). Notifying the leader of your support group, helps in the following ways:

- Helps ensure that there are enough childcare providers available.
- It helps invited speakers/guests preplan their agenda.
- Helps us decide the quantity of snacks, drinks, and handouts.
- Helps to ensure that we have a meeting space that meets everyone's needs
- Helps us to know who we should contact of an unexpected cancelation.

Dear Foster Parent:

The foster care implementation committee has reconvened and is meeting regularly. This group seeks to provide increased, consistent and timely communication to all involved in the foster care program. It is our goal to provide information to you at least once a month.

Since November 2011, OCFS staff met with kinship and foster care families, youth and agencies. OCFS staff value your thoughts, ideas and concerns, and we appreciate all the information that you have provided. We recognize that there have been challenges in completing this process. We know that families who provide foster care need supports and deserve to be reimbursed in a prompt and fair manner.

Foster care implementation will follow four tenets:

- 1. Every child who enters foster care will have a safe placement.
- 2. Transition supports will be available for all youth in care.
- 3. Resource families will be engaged during the time that youth are either in residential care or are hospitalized, allowing for a timely transition back to a community/least restrictive setting.
- 4. All families, including Kinship families, need supports and reasonable compensation for the care they provide to youth.

The committee recognizes the overarching need for careful regard and sequencing of steps in implementing improved services to meet the needs of children in care, while actively supporting the families who provide foster and kinship care for these children.
