Have you Heard About WIC?

WIC is a nutrition program for thousands of Maine families, helping Maine kids to grow up strong and healthy. WIC food benefits are available based on income guidelines and up-to-date nutrition research. WIC seeks to serve all Maine families with healthy foods, including formula, free nutrition advice, tips for staying healthy, Breastfeeding Support and supplies and resources for growing families. WIC is complete nutrition care.

WIC is open to anyone living in Maine, including migrants working in Maine. Applicants can be any of the following:

- Women who are pregnant, breastfeeding or had a baby in the last six months.
- Infants and children up to the age of five, including adopted and foster children.
 - Fathers may apply for their children.

People on SNAP, MaineCare or TANF are automatically eligible for WIC.

A Proclamation on National Adoption Month, 2021

Every child deserves to grow up with a safe and loving family, with the care and support of their community. During National Adoption Month, we celebrate all of the children and families nurtured, enriched, and made whole by adoption and recommit ourselves to ensuring that every child in America can grow up in a loving and supportive home.

The COVID-19 pandemic has made it especially challenging for children in the foster care system. For thousands of young people in foster care, navigating the challenges of growing up can be especially difficult without stable family connections. Because of the added difficulties imposed by the pandemic, my Administration has implemented the substantial investments made through the Supporting Foster Youth and Families Through the Pandemic Act to help older adolescents transitioning from the foster care system maintain housing, stay in school, pay the bills, and lay a strong foundation for adulthood. My Administration encourages States to continue using these available funds to support older foster youth in every way they can.

During this month, we also acknowledge the history of injustices and racial bias in our Nation's child welfare system. To this day, Black and Native American children are more likely to be removed from their homes, more likely to stay in care longer, and less likely to be adopted than white children. To ensure the equal dignity and care of all our children, we must improve our efforts to keep families together, prevent the trauma of unnecessary child removal, and recruit and support new adoptive families — especially kinship caregivers. Finally, we must further support families who have already taken youth into their homes and invest the time and energy needed to ensure that all children — including LGBTQ+ youth whose needs are not always met in the foster care system — can find the happiness and well-being that every child and young person deserves.

This National Adoption Month, we celebrate the families who have been forged through adoption, including from foster care. We extend our gratitude to the dedicated professionals who work tirelessly to support adoptive families through compassion and hard work and to the foster families who love, care, and provide for our Nation's foster youth. Most importantly, we acknowledge the strength and resiliency of the children and youth who are still waiting to find their forever homes.

NOW, THEREFORE I, JOSEPH R. BIDEN JR., President of the United States of America, by virtue of the authority vested in me by the Constitution and the laws of the United States, do hereby proclaim November 2021 as National Adoption Month. I encourage all Americans to observe this month by helping children and youth in need of a permanent home secure a more promising future with a forever family and enter adulthood with the love and connections that are so important to their growth.

IN WITNESS WHEREOF, I have hereunto set my hand this twenty-ninth day of October, in the year of our Lord two thousand twenty-one, and of the Independence of the United States of America the two hundred and forty-sixth.

Upcoming Training

NACAC's One-Day Virtual Conference on FASD December 8, 2021 10:30AM-4:30PM

NACAC will present a virtual conference on fetal alcohol spectrum disorders (FASD). Presenters include knowledgeable, solution-focused experts who have lived experience with FASD.

Fetal alcohol spectrum disorders are some of the most common—yet underdiagnosed—challenges facing children and families in adoption and foster care. NACAC's conference will highlight solutions for parents and professionals related to these disorders that are 10 times more common in foster care than they are in the general population. Even if you don't know you are working with or parenting a child with an FASD, you may well be.

The conference features the following sessions:

- Welcome and Introduction with Phyllis Stevens, foster and adoptive parent In this session, Phyllis will share her experience of realizing belatedly that her daughter had FASD and how understanding FASD changed their relationship.
- Making the Connection Between the Brain and Behavior in Fetal Alcohol Spectrum Disorders with Dan Dubovsky, MSW, therapist, experienced FASD trainer, and parent Because the effects of prenatal alcohol exposure on the developing brain often lead to challenging behaviors, it is essential that solutions begin with understanding the brain basis of FASD. Dan connects the dots between brain functioning and behaviors and stresses the importance of implementing a positive focused system of care.
- Living and Thriving with FASD with Hope & Tyler Martindale-Davis and Mark Martindale; facilitated by Phyllis Stevens In this session, a young adult who has an FASD, her husband, and her father will share their story of living with FASD and loving someone with an FASD. The panelists will share strategies and approaches that have helped them learn to thrive as individuals and in their relationships.
- Strategies and Solutions for Children with an FASD with Barb Clark and Ed Morales, MPP, MSW, LICSW, parents/professionals Understanding what FASD is and how it affects a child are the first steps to becoming FASD competent, but we can't stop there. This session will give supporters—both professionals and families—an understanding of why typical approaches often don't work with FASD. Learn to think outside the box, using approaches that promote relationship and emotional well-being.
- Registration is \$50 per person (or couple viewing sessions together) for NACAC members or \$60 for non-members. Attendees can participate live or listen to a recorded version of workshops.

This workshop will cover the definition of discipline along with 7 principles of discipline which are introduced through group work and class discussion. These principles of discipline will give you tools to use at home.
