Ms. Hirsh-Wright sits on multiple state and national committees and Boards that focus on childhood exposure to trauma, trauma-informed care, and resilience, and she has authored multiple resources on the topics of STS and resilience. Are you Aware of AFFM's Passes or Discount Card Program? Here's What you Need to Know.

It is important that you call AFFM at 827-2331 with the date you wish to visit a museum, the wildlife park, or Pineland Farms as it's still required only one resource family attends per day. Your AFFM Discount Card acts as your pass for up to 6 people for a day's visit to the children's museums. *Note, stickers for your discount card are not automatically mailed out. If you are in need of a 2023 sticker, please call the office or email info@affm.net State Park passes are still available to licensed foster homes. If you are interested in receiving a state park pass please contact AFFM. We ask that you have your foster care Id number (found on your license), readily available.

HAVE YOU ATTENDED A C.A.R.E.S. MEETING?

C.A.R.E.S. meetings allow for families to make connections and form relationships with other families and find support that can last a lifetime. People who attend often find others that are in a similar situation as their own. Members of a meeting may share their personal experiences and offer one another emotional comfort and moral support. C.A.R.E.S. meetings provide practical advice and tips to help families cope with the challenges and joys of being a resource family. In-person meetings typically have onsite child care which allows kids to interact with other kids who are experiencing similar life events. Youth benefit from knowing that they are not alone, and others are experiencing similar situations.

This opportunity is a great resource for the whole family and provides many other benefits including but not limited to:

Gaining a sense of empowerment and control.

Improving your coping skills and sense of adjustment.

Talking openly and honestly about your feelings.

Reducing stress, fatigue, or a sense of isolation.

Developing a clearer understanding of what to expect with your situation.

Getting practical advice or information about additional support options.
