### OCFS Announcement

{OCFS} is pleased to announce that Julie Panicci (formally McShane) has been hired as the Resource Parent Program Manager within the Office of Child and Family Services (OCFS). Julie has a BS in Sociology and holds a Master of Social Work, from the University of New England. Julie was employed with the OCFS for 21 years and has worked as a permanency/adoption caseworker and an adoption supervisor in District 1 before transitioning to her last role within OCFS was as the Program Administrator in District 2. Julie was involved in many different initiatives and committees that helped to improve practice and implement change. She developed stakeholder engagement to strengthened and evaluate district needs.

### OCFS Announcement continued...

In 2019, Julie began working for The Cutler Institute as a Policy Associate II for Child Welfare Development. There, Julie collaborated with the State of Maine to help identify organizational/programmatic issues and trends and assess resources and barriers for organizational improvement.

She also implemented a model training system for child welfare staff and resource families that align with the agency's policies, model of practice and legal requirements to support the workforce.



### Continued...

In 2021, Julie moved to doing the same type of work in the State of NH, at UNH and held the role as the Program Director for the Child Welfare Educational Partnership. Here she oversaw the contract with the NH Division of Health and Human Services to provide a broad range of educational programs, research, and development of training activities to all staff, foster and adoptive parents, and residential care providers at the NH Division of Children, Youth and Families. In 2024, Julie became a Child and Family Program Specialist for the Children's Bureau out of the US Department of Health and Human Services. Here, she provided oversight and coordination of federal child welfare programs, ensuring successful implementation of policies and guidelines to improve services to children and families.

We are very excited to be welcoming Julie back into the OCFS. She will begin this role on June 16, 2025 and will be stationed out of the Portland Office.

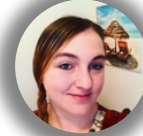
